

LINCOLN CENTER INSTITUTE'S SUMMER SESSION 2010 P IN-SERVICE CREDIT INFORMATION SHEET

The following is a list of the P in-service credit available through Lincoln Center Institute's Summer Session workshops:

P IN-SERVICE CREDIT

Please note that P In-Service Credit is available to NYC teachers attending the following Summer Session Courses:

Introduction to Imaginative Learning through Aesthetic Education course, July 12-16: Open to teachers who work at an LCI-affiliated school.

Lincoln Center Institute International Educator Workshop (Introductory), July 12-16: Open to educators and administrators nationwide who are new to LCI's program and whose schools are not currently affiliated with LCI

In September, the superintendent or school head and the district coordinator of each participating school receives an attendance report from the Institute listing the number of days each participant attended the Summer Session. Teachers from districts outside New York City should make in-service credit arrangements directly with their school administration since the Institute does not determine whether in-service credit is available or how many credits are awarded.

"P" in-service credit (for New York City School teachers):

"P" in-service credit may be applied toward the completion of the first or second salary differential requirements. Approved "P" In-Service credit is granted at the rate of 3 in-service credits per 30 hours of instruction.

Teachers attending either the Introduction to Imaginative Learning through Aesthetic Education course or the International Educator Workshop introductory course may take these courses for three "P" credits through the NYC Department of Education's After School Professional Development Program.

To register for P Credit:

All registration for P Credit must be done online through the New York After-School Professional Development Program's web site at <http://schools.nyc.gov/Teachers/aspdp>. Registration for LCI participants will begin on **June 1, 2010 and continue through first day of LCI courses (see above)**. Please note that no registration will be available at the LCI front desk during Summer Session. You must register online at the web site listed above.

P Credit tuition fees:

There is a \$100.00 non-refundable ASPDP course fee. There is no additional fee for teachers from LCI-affiliated schools. For NYC teachers attending the International Educators Workshop or there is an additional fee of \$200, plus a \$30 materials fee, to be paid through ASPDP. **Please note: all payments must be in the form of a credit card. No checks or cash will be accepted.** Participants may pay with VISA, MasterCard or Discover Card at <http://schools.nyc.gov/Teachers/aspdp>. No payment will be made to Lincoln Center Institute.

Requirements for receiving three "P" credits are:

- Regular attendance for a minimum of 30 hours (5 workshop days) from July 12-16, 2010 from 9:30 a.m. to 4:30 p.m. for the Introduction to Imaginative Learning and from 9:00 a.m.-4:30 p.m. for the International Educators Workshop
- One lunchtime meeting with “P” credit instructor on Monday, July 12, 12:45-1:15, location TBD. Keep journal and reflection sheets (as required of all new Institute participants)
- Final paper assignment due by August 1 (required of P Credit registrants specifically)

Certification:

The workshop attendance records and course grade report will be sent to the New York City After School Professional Development Program Office once the final assignment is completed. A course certificate will then be sent to you by that office. Participants should allow 10-12 weeks to receive the certificate.
